Introduction

The Jeanne Clery Act Disclosure of Campus Security Policy and Campus Statistics Act, codified at 20 USC 1092(f) as a part of the Higher Education Act of 1965, is a federal law that requires colleges and universities to disclose certain timely and annual information about campus crime and security policies. All public and private post-secondary educational institutions participating in federal student aid programs are required to comply with it. The law, originally enacted by Congress in 1990 as the Campus Security Act, was initiated by Howard and Connie Clery after their daughter Jeanne was tragically murdered at Lehigh University in 1986.

The Clery Act requires colleges and universities to publish an annual security report by October 1st that contains three years of crime statistics and policy statements including: sexual assault policies, victim's rights, the law enforcement authority of campus police, and procedures for reporting crimes. The annual security report for Cuesta College includes statistics concerning reported crimes that occurred on campus, in certain off-campus buildings or property owned or controlled by Cuesta College, and on public property within, or immediately adjacent to and accessible from the campus.

In accordance with mandated reporting requirements, information concerning the monitoring and recording of any criminal activity in which students have engaged, at off campus locations and/or within student organizations that are officially recognized by Cuesta College, are gathered from local police agencies. These agencies include any City, County, State, or Federal agencies that may have relevant information, and the statistics are published in this disclosure.

The Cuesta College Police Department is responsible for providing the gathered statistics and safety information to all students, staff, faculty, visitors and prospective students and employees of the District. Policies centering on alcohol and drug use, crime prevention reporting, sexual assaults and other matters are gathered and available from various sources at Cuesta College, the community and publically available, online resources.

Policy for Reporting the Annual Disclosure of Crime Statistics



Cuesta College Chief of Police **Bryan Millard** (CCPD) is responsible for compiling and publishing the Annual Security Report to comply with the Clery Act.

This report is a collaborative effort that includes the cooperation of several departments within the College, and all employees designated as Campus Security Authorities (CSA) under the Clery Act. Each CSA is asked to provide information on their educational efforts and programs to comply with components of the Clery Act aimed at Crime Prevention and awareness.

Crime statistics are requested from law enforcement agencies with concurrent law enforcement jurisdiction or jurisdictions surrounding Cuesta College and off-site properties or facilities owned or controlled by Cuesta College. These law enforcement agencies provide crime statistics they have collected for crimes occurring on campus properties or public property immediately adjacent to Cuesta College campuses and/or facilities.

Cuesta College does not have any on or off campus fraternity or sorority houses, and Cuesta College does not officially recognize student organizations in any off campus facilities.

Availability of Annual Security Report

Campus wide emails to all current faculty, staff, and students are sent on or before October 1st, and at the beginning of the Spring and Summer Semesters each school year, regarding the availability of the annual security report on the campus police website, and a statement on how to obtain a paper copy, if desired.

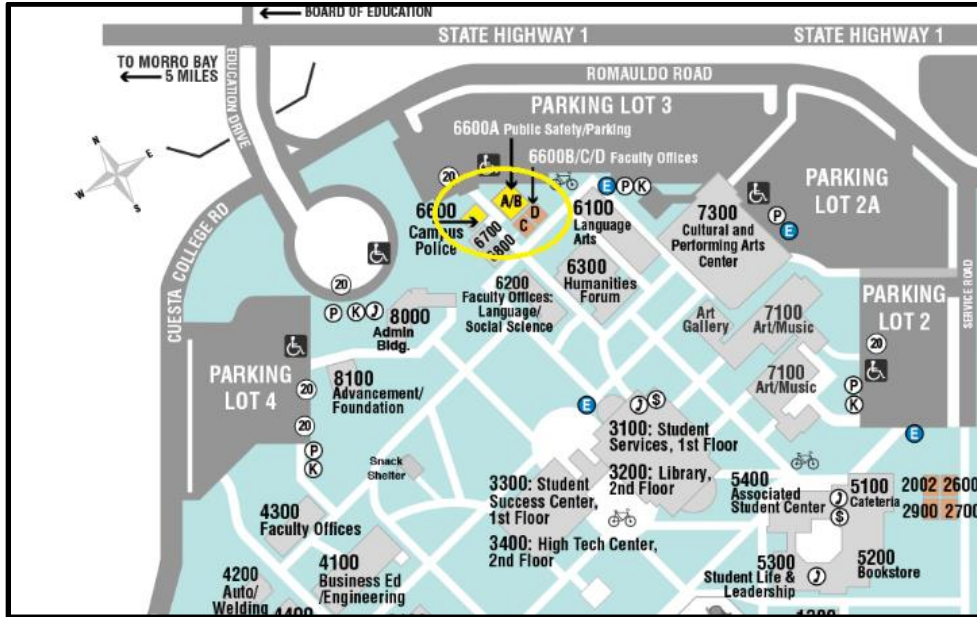

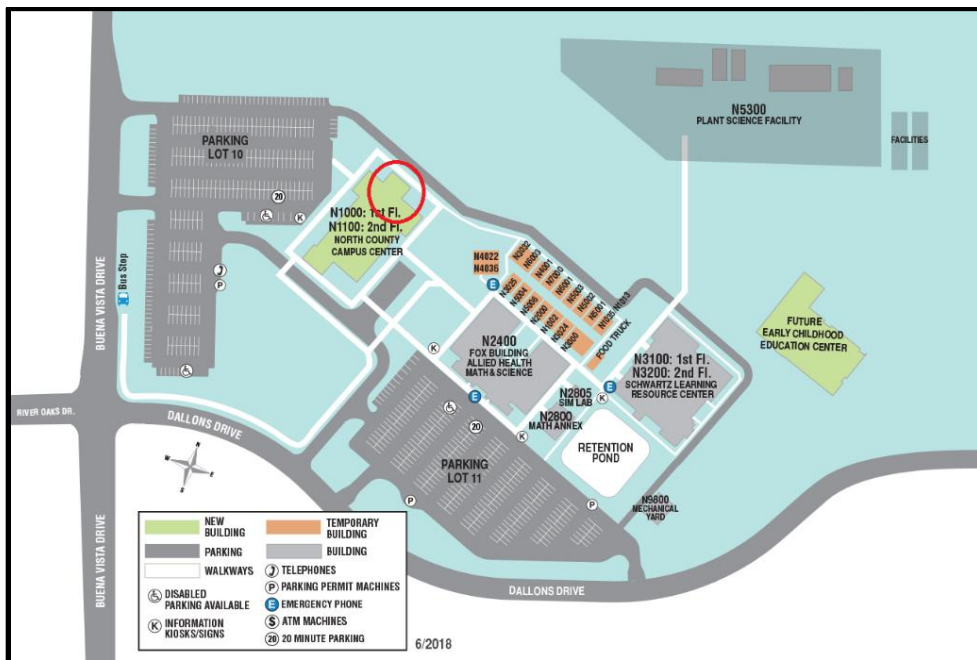
Prospective students receive a notice about the ASR through the registration process on the "My Cuesta" system, which provides the location of the ASR and general information about the Clery and Save Acts.

Law Enforcement Authority, Jurisdiction, and Agreements



Authority:

The Cuesta College Police Department is a full-service, certified police agency within the State of California staffed by sworn police officers and non-sworn professional staff. Officers of CCPD are California Peace Officers per Penal Code Section 830.32. and possess the same authority and powers, including the authority to arrest, as do police officers and deputy sheriffs in other areas of the State. Each Cuesta College Police Officer receives ongoing training in compliance with state of California P.O.S.T. mandates that include firearms, defensive tactics, first aid/CPR, legal updates, and other specialty training as needed.

Jurisdiction:

Officers are responsible for reporting and investigating all crimes, issuing traffic and parking citations, responding to medical and fire emergencies, handling traffic accidents, and handling other incidents requiring law enforcement assistance on all Cuesta College controlled property. This includes the main campus located in San Luis Obispo, the North County Campus located in Paso Robles, and 75 acres of property located adjacent to the San Luis Obispo campus on the opposite side of Hwy 1. All crimes or activity reported regarding our south county center in Arroyo Grande will be handled by to the Arroyo Grande Police Department.

Agreements:

CCPD maintains an excellent working relationship with neighboring law enforcement agencies and has several standing agreements. They include the following:



San Luis Obispo County Sheriff's Office: Major crimes occurring on campus property may exhaust the resources of CCPD. By agreement, the San Luis Obispo Sheriff's Department shall be asked to provide appropriate law enforcement or investigative assistance in those cases. CCPD is able to access state law enforcement databases through this agreement. The Sheriff's department also has jurisdictional authority on the San Luis Obispo Campus for calls involving Rape, Homicide, and reports of missing children and adults. In addition, the Sheriff's department assumes responsibility for the SLO campus and response during times where Cuesta College does not have a sworn officer available. This includes all evenings after the last class is over, on certain weekend days, and during district holidays when CCPD is closed.



Paso Robles Police Department: By agreement, the Paso Robles Police Department has jurisdictional authority over calls on the North County Campus (NCC) located in Paso Robles that include reports of Rape, Homicide, and reports of missing children and adults. In addition, the Paso Robles Police Department assumes responsibility for the NCC campus and response during times where Cuesta College does not have a sworn officer available. This includes all evenings after the last class is over, on Saturdays and Sundays, and during district holidays when CCPD is closed.



Arroyo Grande Police Department: By agreement, the Arroyo Grande Police Department has jurisdictional authority over all law enforcement activities on the Arroyo Grande High School campus, where the Cuesta College south county center is located. The Arroyo Grande Police Department will notify the Cuesta College Police Department of any such crime involving the Cuesta College south county center.



California Highway Patrol: By agreement, the California Highway Patrol provides assistance to Cuesta College in cases of major and/or fatal traffic collisions, where such investigations are beyond the scope of resources for CCPD. The CHP also responds to and takes over investigations from Cuesta College related to driving under the influence or alcohol and/or drugs.

Campus Safety Plan

In compliance with 67380 of the California Education Code, this annual security report incorporates required elements of a campus safety plan. Those elements are: *the availability and location of security personnel, methods for summoning assistance of security personnel, any special safeguards that have been established for particular facilities or activities, any actions taken in the preceding 18 months to increase safety, and any changes in safety precautions expected to be made during the next 24 months.*

Preceding 18 Months:

- *Updated Emergency Messaging System* – Cuesta College recently upgraded our emergency messaging system to a new provider, Rave Mobile Safety, which improves reliability and functionality in context with a new Mobile Safety application. There is now a “text to join” feature available for outside visitors to the campus who want to receive emergency messages at Cuesta.
- *Trauma Response Kits* – Due to a grant provided by Associated Students of Cuesta College, Cuesta PD added 5 blood trauma response kits to areas of both the San Luis Obispo and the North County Campus. These kits allow anyone in the Cuesta community to access potentially lifesaving tourniquets and first aid supplies in the event of a mass casualty situation.
- *Updated Safety Training* – Cuesta College Police personnel updated the campus safety presentations to both staff and students to include additional training in how to respond to an active shooter and how to stop blood trauma injuries using equipment available in the new Trauma Response Kits on our campuses.
- *Mobile Safety Application* – Cuesta PD added a mobile safety application available to all students, staff, and visitors known as “Rave Guardian”. This application allows one-touch reporting to campus police, GPS location capability for responding police personnel, text-to-tip reporting for criminal or suspicious activity, and current emergency procedure information
- *Emergency Operations Center (EOC) Upgrade* – Cuesta College Police purchased a set of new laptops for use in the Emergency Operations Center. This helps Cuesta College integrate with web-based EOC management and communications known as “WEB EOC”, which is used by San Luis Obispo County and all local municipalities.
- *Enhanced Traffic Safety Signage* – Due to a grant from the Campus Safety Committee, Cuesta College Police purchased new Hi-visibility stop signs with LED flashers, installed on high traffic intersections in order to promote awareness of the stop signs and reduce traffic safety risk.

Next 24 Months:

- Updated Emergency Plans – During the next year, the Chief of Police, who also serves as the Emergency Director, will be working with a diverse planning team of Cuesta College staff, student, and community representatives to re-write and upgrade our emergency response plans for the college district.
- Surveillance Cameras – Cuesta PD will be coordinating with Information Technology, Facilities, and college administration for the policy and placement of advanced surveillance cameras on college district property. This long-term project will allow Cuesta PD to accurately identify criminal activity on campus and serve as a crime deterrent due to their presence in areas such as parking lots, where many of our reported crimes take place.
- Emergency Response Trailer – Cuesta PD has acquired a utility storage trailer that will be converted into an emergency response asset for the college district. Utilizing a grant received from the Associated Students, this trailer will be outfitted with emergency food rations, disaster response tools, and first aid equipment to provide for the college community during a natural disaster or large-scale emergency.
- Upgraded North County Campus Radio System – Cuesta College Police are working with Information Technology and an outside vendor to enhance the radio system coverage for the north campus. The long-term goal is to also add capability for this system to connect with the SLO campus under one centrally controlled dispatch system.
- Upgraded SLO Campus Radio System – Cuesta College Police will work to establish a secondary emergency frequency for vulnerable populations and campus administrators to use and communicate with Campus Police Dispatch during an emergency.
- Enhanced Emergency Operations Training – During our annual earthquake emergency drill this fall, Cuesta College Police will be conducting a drill to open and utilize the Emergency Operations Center. This drill will incorporate a use of our upgraded messaging system to recall EOC workers to the Center.
- Additional Emergency Phone locations – 2 new locations are planned for (blue light) emergency phones at the North Campus. This includes the new Parking Lot 12 near the children’s center and parking Lot 10, near the campus center.
- Department Website Updates – Cuesta PD provides a wealth of campus safety resources on the department website. This will be updated this next year with new information about our campus safety app, Rave Guardian.

Access and Security of Campus Facilities

Cuesta College Police Department maintains overall responsibility for the security and access to all Cuesta College owned facilities and properties. Police Officers and Public Safety Officers conduct routine patrols of the campus properties to ensure the safety and security of the college, as well as identify any repairs or maintenance to the security infrastructure that is needed. CCPD unlocks campus buildings in the morning prior to business hours, and checks to make sure that buildings are locked in the evening hours prior to campus closure.

CCPD also maintains control and records for all keys provided to employees of Cuesta College for authorized building access. The Facilities department assists the Police Department with maintenance and installation of all locking mechanisms, including updated keypad access locks on certain buildings.

A building security alarm system is active at critical locations throughout campus during evening hours when the campus is closed. The Facilities department maintains the contract and assures maintenance of those alarms. The Chief of Police and designated members of CCPD are on a call out list and will respond to building alarms during all hours of the evening if needed.

Cuesta College does not have any on or off campus student housing. During hours when the campus is closed, the San Luis Obispo County Sheriff will provide security and emergency response to the SLO campus while the Paso Robles Police Department will provide the same to the North County Campus.

How to Access Daily Crime Logs

The Cuesta College Police Department maintains a Daily Log that is available for public view. This log contains a record of all crimes reported to the Department, and provides the nature of the initial complaint, the date and time reported, the general location of the incident, and the disposition of the incident. A hardcopy of this log is available by request at the Cuesta College Public Safety Offices, SLO campus Building 6600A or at North County Campus building N1021, from 8:30 AM to 4:00 PM, Monday through Friday.

Reporting Crimes and Emergencies

Suspected criminal or suspicious activity and other emergencies that occur on campus should be immediately reported to the Cuesta College Police Department. This ensures that CCPD can take prompt action to provide or restore a safe learning environment for the college community. CCPD responds to all on-campus reports of fire, police, and medical emergencies, as well as any emergency or other suspicious incident close to our campus property.

Emergencies and/or crimes can be reported in the following ways:

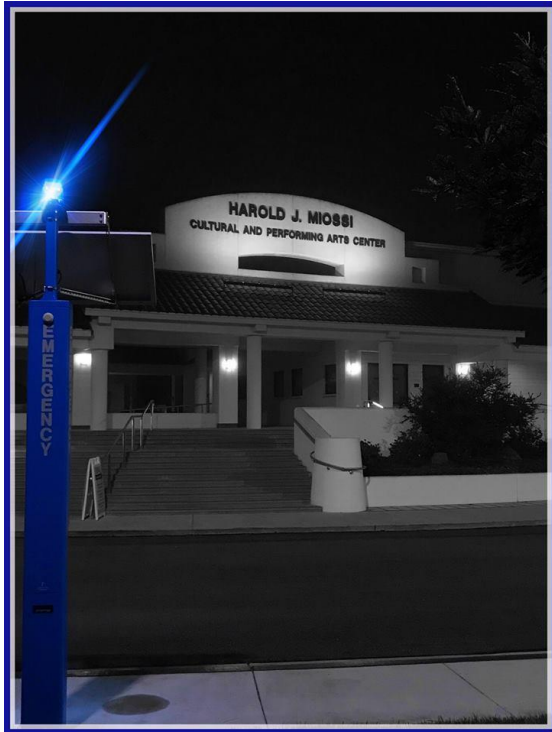
- **3911** from any on-campus telephone (San Luis Obispo campus)
- **4911** from any on-campus telephone (North County Campus)
- Pushing the red button on (blue light) emergency phones at both campuses
- Calling the police department directly at **805-546-3205** (San Luis Obispo campus) or **805-591-6205** (North County campus).
- Off-campus or unsure of location, **dial 911**
- Through our Campus Safety App, Rave Guardian

The Cuesta College Police Department has primary law enforcement jurisdiction for all criminal incidents (with the exceptions of Murder, Manslaughter, and Rape) that occur on our campuses. This includes incident investigation, follow-up and resolution. Police officers will be dispatched to all crimes in progress and other emergencies along with the appropriate fire and medical personnel.

If you are off campus or unsure of the jurisdiction you are in, contact CCPD at: 805-546-3205 or dial **911** for an emergency. Emergency "Blue Light" Telephones:



There are **7** emergency "blue light" call towers located on the San Luis Obispo campus and **3** on the North County Campus. These telephones allow anyone to contact a Police Dispatcher when classes are in session by pushing a large red button on the face of the tower. Calls go directly to Cuesta College Police Dispatch. These telephones do not provide access to general telephone services.

If the phone is not answered, it will be automatically routed to the San Luis Obispo County Sheriff's Department. All emergency telephones are painted blue with the word "Emergency" in white lettering across both sides and are located in the following locations:

SLO Campus

- Telephone 1 – In Parking Lot 2A next to the Performing Arts Center
- Telephone 2 – In Parking Lot 3 adjacent to Building 6100
- Telephone 3 – In front of the Library, Building 3100/3200
- Telephone 4 – Lot 2, adjacent to the cafeteria
- Telephone 5 – Between Buildings 2000 and 4400
- Telephone 6 – Adjacent to the Gym, Building 1400, on Chorro Valley Rd
- Telephone 7 – At 75 Acres, adjacent to the work structures

NCC Campus

- Telephone 1 – In the courtyard between the Fox and Schwartz buildings
- Telephone 2 – In lot 11, facing the Fox building
- Telephone 3 – Adjacent to the Children's Center

Non-Emergencies On-Campus:

The non-emergency, business telephone number to reach the Cuesta College Police Department is **805-546-3205** for the San Luis Obispo campus and **805-591-6205** for the North County Campus. Please understand that the dispatcher must answer all calls and that you may be placed on hold if you do not have an emergency.

**Note:* When dialing 911 from a cellular phone, you will be connected to the California Highway Patrol Dispatch Center or the closest police department to your location. Be prepared to provide dispatcher with the city, county, and specific location where the emergency response is needed.

Student Incident and Well-Being Reports

Cuesta College provides a format for written documentation of observed criminal acts, suspicious activity, or concerns about the well-being of a Cuesta College Student. The Student Incident and Well-Being report is available at the Office of the Vice President for Student Services, in room 3172 on the SLO campus, and at the following website address:

*Note**A fillable version that can be submitted electronically is also available to Cuesta College staff through the My Cuesta login under the work life tab, in "Cuesta Forms".

This report allows anyone to document and report observations directly to the Student Incident Response Team (SIRT), which includes the Vice President of Student Services, the Chief of Police, a faculty representative, and the Director of the Student Health Center. We encourage those who report these incidents to provide their name and information on the report in order to assist SIRT in developing an ongoing dialogue and resolution with those affected by these incidents.

The SIRT philosophy is to help each student achieve success and meet their personal goals, while protecting and preserving a healthy and safe learning environment for all students. SIRT meets once a week to discuss appropriate response and follow up to written reports. This can include a wide variety of college or community based services (such as counseling), appropriate disciplinary measures resulting from violations of the student code of conduct, or legal action due to reported crimes.

Confidential Crime Reporting

The Cuesta College Police Department recognizes that reporting a crime may represent a personal risk of exposure to the perpetrator of the crime. Our department will do its utmost to ensure that the information of those who report crimes are not disclosed without a legal reason for doing so. If you feel uncomfortable coming forward due to that risk, there are methods for confidentially reporting crimes that are available:

Counselors: Confidential reports may also be made to mental health counselors at the **Cuesta College Student Health Center**. Certain crimes however, based on their severity, may require that the counselor disclose the information to legal authorities. A counselor should inform you of these exceptions prior to your report of such a crime. An example of this is the crime of murder.

Crime of sexual assault, dating violence, and stalking may also be reported to the Cuesta College Title IX coordinator, who is currently the Vice President in charge of Human Resources. A link to that page is below:

Campus Safety App



Cuesta College partners with Rave Mobile Safety to provide the Campus Safety App, "Rave Guardian" to all students and staff. This app is free to download for all apple and android devices through the device appropriate app store. Simply type in "Rave Guardian" and follow the on-screen instructions to download and install. Rave Guardian is a comprehensive Campus Safety "tool-box" for communications and campus resources including:



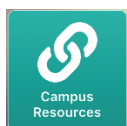
Inbox – This feature provides a method to send targeted "push-notification" alerts to Guardian users, even when the user does not have a cellular signal.



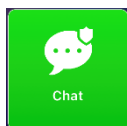
Call Directory – This contains telephone numbers for commonly used resources at Cuesta like the Health Services, Financial Aid, and Academic Counseling, as well as the suicide prevention hotline, among others.



Safety Timers – Friends and family can serve as a "virtual escort" using this feature. App users set a timer, tell their Guardian where they are going, and decide when their Guardians can call and check on them.



Campus Resources – This provides a helpful list of campus resource links, such as campus maps, academic and student life calendars, as well as our current emergency information and annual security report.



Chat – This feature allows the user to text message the on-duty Cuesta Police Dispatcher. The user can also attach pictures, when reporting graffiti, or text anonymously, allowing confidential crime reporting.



Campus Police – This allows the user to call campus police without need of the telephone number. The user can also choose to share their GPS location, allowing an expedient police and medical response.

Timely Warning Alerts

A well-informed community is an integral component in maintaining the safest campuses and facilities possible. At Cuesta College, the Police Chief and/or designee confers with the Superintendent/President or designee, legal counsel, and involved law enforcement agencies after a violent crime or crime listed in the Clery Act is reported to the Cuesta College Police Department. Depending on the circumstances and facts, a determination is made whether the incident reported represents an on-going or continuing threat to Cuesta College.

Once a determination is reached that a continuing threat exists, the Chief of Police and/or designee will arrange to disseminate a "Timely Warning" crime alert as soon as possible through the Cuesta College My Alert notification system, the Cuesta College Foundation (news media, social media), and other communication methods as needed: CCPD Facebook page, police vehicle public address systems, the college wide email system, and/or the physical posting of Timely Warnings to ensure all members of the Cuesta College community and the surrounding community are likely to have access to the information.

Emergency Response and Notifications

In matters where there is a significant emergency or dangerous incident that poses an immediate threat to the members of the Cuesta College community, the Cuesta College Police Department will utilize various communication methods to provide *immediate* emergency notifications to campus community members. These communication methods include the following:



My Alert: Cuesta College provides a mass message distribution system that is available to all students, staff, and faculty, who sign up via their "My Cuesta" login page.

The My Alert system allows CCPD authorities to send out emergency notifications and timely warnings to all enabled cellular telephones and emails of those who elect to sign up for this system. The notifications can include text and email notifications. CCPD maintains responsibility and authority for this system, with technical support from the Cuesta

College department of Information Technology. Information about My Alert 2.0 can be found here:

CELS:

A secondary communication system, used in compliment to the My Alert system, is the **Campus Emergency Lighting System (CELS)**. CELS provides a visual enhancement to emergency communication through a 4-color light panel placed throughout both the San Luis Obispo and North County campuses, in areas where multiple people gather together. Examples of these areas are classrooms, lobbies, athletic facilities, and conference rooms among many others.



CELS provides the following visual emergency notifications, based on an established color code:

- **Flashing Red** – evacuate building immediately
- **Solid Red** – Lock the door and shelter in place
- **Amber** – Caution alert, standby for My Alert message
- **White** – All clear
- **Green** – Danger has passed

Cuesta College Police Department will activate the CELS during emergency situations based on the decision of the Chief of Police or his/her designee. Further information about CELS is available here:

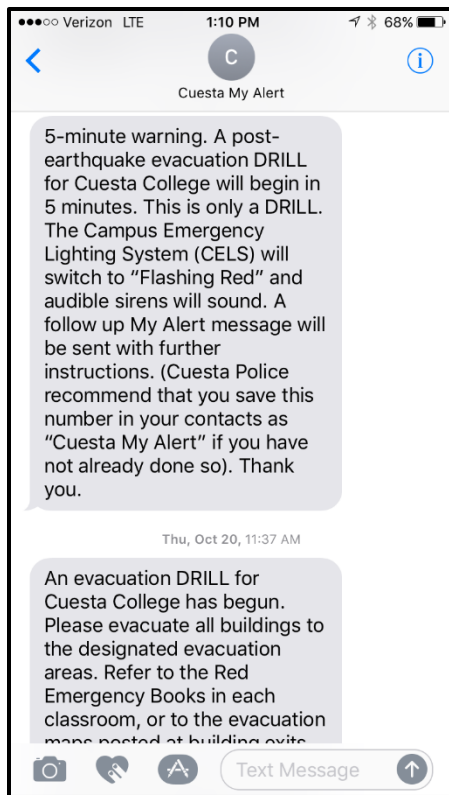
Other emergency communication methods may include but not be limited to: *public address systems in emergency vehicles, audible sirens, fire alarms, hand-held bullhorns, the campus telephone system, panic buttons, posted bulletins at relevant campus locations, the Cuesta College website, and both the Cuesta College and campus police Facebook pages.*

Emergency Response:

When a significant emergency or dangerous situation is reported to Cuesta College, CCPD will immediately respond to mitigate, contain, and/or resolve the incident. Once the Police have assessed the situation, they will relay pertinent information through the police chain of command to the Chief of Police or his/her designee. The Chief of Police or ranking designee will determine the appropriate course of action and the necessity of an emergency notification to the campus community. This will also include a notification and consultation with the College President or their designee, and any other emergency personnel specific to the type of event (e.g. fire official in the event of fire).

CCPD, in order to provide for timely emergency communications, maintains a "Crisis Action Team" list of telephone contacts and distributes this list to those authorities named. This team includes members from various disciplines, up to and including the College President, Chief of Police, and other designees with significant responsibilities at the college.

Timeliness of Notifications:



In sending an Emergency Notification, Cuesta College recognizes that the campus community needs prompt communication of the emergency or dangerous situation in order to provide for a safe learning environment. The college will immediately, while considering the safety of the community, determine the content of the notification and initiate the notification system(s).

The segment of the campus community who receive the notification, through any or all of the listed communication methods, will be determined by the Chief of Police or the ranking Police Department designee, based on the scope of the emergency or dangerous situation. For example, a situation contained solely at the SLO campus may not necessitate a notification to the North County Campus, depending on the details of the situation. Any emergency notification sent out over the My Alert system, however, will be sent to all users, regardless of the location of the incident.

The overall timing of the notification, *may* be delayed only if, in the reasonable and professional judgment of responsible authorities, initiating the message will otherwise compromise efforts to safely assist victims or contain, respond to, or otherwise mitigate the emergency.

Responsible Authorities for Notifications:

The Police Chief or his/her designee is responsible for the overall decision to send an emergency notification, based on the information available at that time.

Notifications on My Alert and CELS will be made electronically by the following authorities with access and authority to the My Alert notification system:

1. Police Dispatch
2. Police Chief
3. Police Sergeant
4. Police Officers
5. Marketing and Public Information: (In the event Public Safety is busy with the emergency)
6. President/Superintendent's Office: (In the event Public Safety is busy with the emergency)
7. Information Technology: (In the event Public Safety is busy with the emergency)

Disseminating Emergency Information to the Community:



Local Media Outlets are encouraged to sign up for the My Alert system, so that emergency situations can be quickly broadcast to the surrounding community. This may also be accomplished through postings to the College and Police Department Facebook, Instagram, and Twitter pages.

The Cuesta College Foundation, and designated Public Information Officer, is responsible for coordinating outside media and community messaging in order to disseminate emergency notifications to the surrounding community.

Emergency Procedures Information

Emergency Operations Plan:

The Chief of Police or his/her designee is responsible for the maintenance and updates to the Cuesta College Emergency Operations Plan (EOP). The EOP contains a comprehensive response protocol to all major emergencies on campus property or that affect the college district. The EOP is designed to satisfy state and Federal mandates under the National Incident Management System and Standardized Emergency Management System, utilizing Incident Command System protocols.

The plan provides detailed information about emergency preparation, response, mitigation, and recovery efforts, as well as important contact information. Copies of this manual are kept at both Campus Police Offices, and in the rooms designated as the Cuesta College Emergency Operations Centers.

The Emergency Operations Plan is currently undergoing a major overhaul that is scheduled to be completed during the 2020-2021 school year.

"Red Books":

Cuesta College Police Department maintains an emergency "red book" that is placed into every classroom on both the SLO campus and at the North County Campus. These books contain a priority list of emergency contact information, emergency procedures information, and evacuation maps and procedures.

Evacuations

Emergency evacuations of a building/buildings, large portions of the campus, or even the entire campus may be required due to situations such as a major fire, an explosion, or a major crisis situation. Upon notification of conditions that may merit an evacuation, the Cuesta College President or their designee will make the determination to order an evacuation based on his/her decision or after consultation with the Cuesta College Crisis Action Team and/or the Cuesta College Chief of Police, as circumstances allow.

The content of the evacuation notice will be determined by the Cuesta College President (or designee) and/or the Chief of Police (or designee). Based on the level of the evacuation, the Emergency Operations Center may be activated, or partially activated. Additionally, the Cuesta College President and/or Cuesta College Chief of Police, or their designees, may without consultation, order an evacuation in

extremely dangerous or compelling circumstances, taking into account any and all immediate threats to the Cuesta College community. In such cases, the evacuation order will immediately be initiated.

If an evacuation is ordered, the Cuesta College Police Department will be tasked with directing students, faculty, and staff to designated Emergency Assembly Points. Emergency Assembly Points maps are located next to the Building Evacuation maps in all buildings on campus, and also within the emergency procedures "red books" available in all classroom facilities.

Method of notification: Evacuation information will be disseminated via the Emergency Notification methods discussed above, using the My Alert notification system, the CELS lighting system, the Cuesta College Foundation (news media, Facebook, Twitter), Cuesta College Police Department Facebook page, by the police vehicle public address systems, and the college wide email system to ensure all members of the Cuesta College community as well as the surrounding community are likely to have access to the information. Additionally, audible sirens and fire alarms may be utilized.

**Note: Should a community-wide message be required, the Cuesta College Foundation, Media Relations, will be directed to do so by the Cuesta College President (or designee) and/or the Chief of Police (or designee).*

Emergency System Tests and Drills

Cuesta College believes that preparation and readiness are the key to successful mitigation and protection of life during any emergency situation. As such, the college actively participates in training exercises and drills to ensure the adequate testing and preparation of the in-place emergency procedures and communication methods. This also provides for ongoing training to the Cuesta College Staff in advance of such an emergency. The Chief of Police / Director of Public Safety serves as the Emergency Manager for Cuesta College. As such, he/she is responsible for coordinating these tests and drills annually. These tests and drills include the following:

Great California Shakeout:



In October of each year, Cuesta College participates in an annual state-wide earthquake drill. Information concerning the Great California Shakeout can be found on the following website: <http://www.shakeout.org/california/>

During the Cuesta College implementation of the Shakeout drill, both San Luis Obispo and North County Campuses will be involved. At designated intervals prior to the drill, information will be distributed to all Cuesta College Staff, Faculty, and Students via the campus wide email system informing them of the upcoming drill and providing safety information related to earthquake safety and evacuation procedures for the college.

On the day of the drill, Cuesta College Police personnel coordinates with designated college staff at both SLO and NCC campuses to implement the drill, which incorporates an activation and test of the emergency communication systems: (My Alert, CELS, audible warning sirens, and several building alarms). Cuesta College will use the communication systems listed to notify the campus of the drill and evacuation procedures, and to signal the "all clear" when the drill has concluded.

EOC Activation:

During each school year, the Chief of Police, in consultation with the President/Superintendent, organizes an activation exercise, procedural update, or other relevant training for the Emergency Operations Center at Cuesta College. The exercise incorporates updated training for EOC personnel, as well as a situationally based "table-top" exercise.

The exercise can include cross training elements with appropriate emergency services personnel (ie: Fire, EMS authorities) and may incorporate a response by public safety personnel to a staged incident. The Chief of Police, serving as the emergency manager, designates the scope of the training exercise in consultation with designated college staff.

Armed Intruder:

Cuesta College Police Department personnel participate in ongoing training in preparation for an armed intruder (otherwise known as an active shooter) on campus. This training takes place minimally once per school year. This training can incorporate several elements: Table-top scenario, role playing incident,

firearms training exercise, or other updated methods as determined by the Chief of Police and CCPD training staff.

Campus Security Authorities

The Clery Act defines certain college employees as **Campus Security Authorities**, (CSA) which includes anyone with significant responsibility for students and student activities. CSAs must report any "Clery Act" crime that they become aware of in their daily contact with students. Failure to disclose knowledge of a reportable crime can have lasting impacts, such as continued criminal behavior towards other victims, escalation of a crime towards a specific victim, and large fines to Cuesta College.

Employees such as administrators, deans, directors, department heads, faculty advisors, student academic advisors, student activities advisors, coordinators, and athletic coaches must report Clery crime violations.

Classroom faculty (except for Advisors), Physicians, Psychologists, and most clerical staff are examples of employees who are not required to report crimes under the Clery Act, however the severity of the crime may require you to legally disclose it, such as a murder or other serious felony crime.

**Note: CSAs must report crimes they are witness to in a prompt manner to ensure timely resolution and a safe learning environment.*

Crime Prevention and Awareness Programs

Cuesta College works cooperatively amongst several departments to provide educational materials, programs, and ongoing training to staff and students in support of crime prevention and awareness. These programs include the following:

Online Training:

The department of Human Resources provides ongoing mandated training to address important issues on college campuses. This has included recent training regarding Sexual Violence Awareness and Child Abuse/Neglect.

Drug and Alcohol Abuse Prevention Program:

The Office of the Vice President of Student Services (VPSS) is responsible for coordination of the drug and alcohol abuse prevention program, which includes a cooperative effort by the Deans of SLO and NCC Campuses, the Student Health Center, and the Cuesta College Police Department. The program includes ongoing information posted on the Cuesta College Police Department website concerning the program and laws relating to drug and alcohol abuse:

Connect at Cuesta and Cougar Welcome Days Orientation

Cuesta College Police provides a presentation as part of the "Connect@Cuesta" new student orientation and "Cougar Welcome Days" enrollment orientation. This presentation includes a review of all available safety services on campus. The presentation is in tandem with presentations about mental health services and Title IX investigations.

Alcohol and Drug Free Campus

Zero Tolerance:

Cuesta College is dedicated to providing the best academic and professional experience that can be offered to its students, faculty and staff. The use of illegal drugs and the abuse of alcohol are at cross-purposes to this mission and are **not tolerated** on campus. Cuesta College is fully committed to achieving an Alcohol and Drug free environment for its students and employees, and the Cuesta College Police Department will enforce all local state, and federal laws related to drug and alcohol abuse in compliance with the Drug-Free Schools and Communities Act.

Alcohol:

- Cuesta College prohibits the use, possession, or sales of alcohol on college property.
- Persons under the age of 21 may not consume, possess, or distribute alcohol
- It is unlawful for any person to sell, furnish, or give any alcoholic beverage to anyone under the age of 21
- Minors who use false identification in order to obtain alcoholic beverages are guilty of a misdemeanor

Other Drugs

- Cuesta College prohibits the possession, use, sale, and/or distribution of **illegal* drugs on college property.
- Prescription medication may only be used and possessed by those with a prescription from a licensed health care provider.
- Federal and state statutes specify that persons involved in the use, sale, or distribution of illegal drugs are liable to criminal action, including arrest, fine, and imprisonment

** Illegal Drugs refers to "Controlled Substances" as defined in Schedules I through V, section 22 of the Controlled Substances Act (21 U.S.C. Section 812) and also found in the Health and Safety Code Section 11054-11058.*

Alcohol and Drug Abuse Counseling and Support

Education and support for those who have questions or problems related to alcohol or drug abuse are available and strongly encouraged. Academic, personal and professional success is Cuesta College's goal for all of its students, faculty, and staff. This goal cannot be achieved if drugs or alcohol are allowed to hinder each person's natural abilities.

The Office of the Vice President of Student Services oversees the Cuesta College Alcohol and Drug Abuse Prevention program designed to assist students, staff, and faculty achieve success.

Information About Registered Sex Offenders

Convicted sex offenders are required by law to register with the law enforcement agency having jurisdiction where the offender lives. Convicted sex offenders are also required to register with the Cuesta College Police Department if they are enrolled as a student of the College or employed by the college (*either full time or part time, including paid employees or volunteers*). Sex Offenders are also required to register if they are working at the college (e.g. contractors) for more than fourteen days or for an aggregate period exceeding thirty days in a calendar year.

In addition, Megan's Law makes information on "serious" and "high-risk" sex offenders in their local community available to adults and organizations. Available Megan's Law information includes: Name and known aliases, Age and sex, Physical description (including scars, marks and tattoos), Photograph, (*if available*), Crimes resulting in registration, County of residence, Zip code (*based on last registration*)

The Cuesta College Police Department does not maintain a public database of registrants at Cuesta College. Information regarding registered sex offenders on campus may be obtained by viewing the Megan's Law website:

www.meganslaw.ca.gov. An offender's campus involvement will be listed as a secondary registration location.

Sexual Assault, Domestic Violence, Dating Violence, and Stalking

Cuesta College does not tolerate sexual assault, domestic violence, dating violence, or stalking in any form.

Any sexual assault or physical abuse, including, but not limited to, rape, domestic violence, dating violence, sexual assault, or stalking, as defined by California law, whether committed by an employee, student, or member of the public, occurring on District property, in connection with all the academic, educational, extracurricular, athletic, and other programs of the District, whether those programs take place in the District's facilities or at another location, or on an off-campus site or facility maintained by the District, or on grounds or facilities maintained by a student organization, is a violation of District policies and regulations, and is subject to all applicable punishment, including criminal procedures and employee or student discipline procedures.

Education and Prevention

Every effort is made to ensure that our educational environment offers prevention related education and training, promotes and assists the prompt reporting of related crimes, and provides compassionate support services for survivors of sexual assault, domestic violence, dating violence, and Stalking.

Definitions:

- **Sexual assault** includes but is not limited to, rape, forced sodomy, forced oral copulation, rape by a foreign object, sexual battery, or threat of sexual assault.
- **Consent** is the affirmative, unambiguous, and voluntary agreement to engage in a specific sexual activity during a sexual encounter. Under this definition, an individual who is asleep, mentally or physically incapacitated as a result of drugs or alcohol, under the age of 18, or who was under duress, threat, coercion or force, would not be able to consent. Consent can be withdrawn at any time during the encounter.
- **Dating violence** means violence committed by a person who is or has been in a social relationship of a romantic or intimate nature with the victim. The existence of a romantic or intimate relationship will be determined based on the length of the relationship, the type of relationship and the frequency of interaction between the persons involved in the relationship.
- **Domestic violence** includes felony or misdemeanor crimes of violence committed by:
 - a current or former spouse of the victim;
 - a person with whom the victim shares a child in common;
 - a person who is cohabitating with or has cohabitated with the victim as a spouse;

- a person similarly situated to a spouse of the victim under California law; or
- any other person against an adult or youth victim who is protected from that person's acts under California law.
- **Stalking** means engaging in a course of conduct directed at a specific person that would cause a reasonable person to fear for his or her safety or the safety of others, or to suffer substantial emotional distress.

Prevention Strategies

Bystander Intervention:

Don't just be a bystander. Be a POSITIVE bystander.

Positive bystanders are individuals who witness situations that could lead to violent or criminal events and choose to intervene to prevent the situation from continuing or escalating. The positive bystander model promotes the idea that everyone in the community has a role to play in preventing sexual violence. This model helps shift the responsibility for preventing sexual violence from the victim (or potential victim) to the person perpetrating the violence and the individuals who witness the behavior.

Here are steps you can take:

1. Recognize an event as inappropriate or sexually violent.

These behaviors range from sexist or derogatory language to trying to take an intoxicated person up to a bedroom. Other inappropriate or potentially sexually violent behaviors include intentionally trying to get someone else intoxicated or trying to take advantage of someone who is intoxicated.

2. Assume personal responsibility.

Research shows that when more bystanders are present for an emergency or situation that could lead to a criminal event, bystanders are less likely to intervene. When more bystanders are present, individuals assume others will step in and intervene. You can make a real difference by assuming responsibility and stepping in to help the situation.

3. Determine how to help (and maintain personal safety).

*Once you have made the decision to intervene, it is important to come up with an intervention strategy that is productive for the situation and ensures your safety, as well as for those involved. You can be creative in your approach; it does not always have to be confrontational. Try using one of the four strategies below: **D**irect, **D**istract, **D**elegate, or **D**elay.*

4. Speak UP and intervene!

Now that you have thought through your strategy, carry out your plan. After you have intervened, check in with the person needing help to make sure they are okay and they feel safe.

Bystander Intervention Techniques

Direct: Step in and address the situation directly. This might look like saying, "That's not cool. Please stop." or "Hey, leave them alone." This technique tends to work better when the person that you're trying to stop is someone that knows and trusts you. It does not work well when drugs or alcohol are being used because someone's ability to have a conversation with you about what is going on may be impaired, and they are more likely to become defensive.

Distract: Distract either person in the situation to intervene. This might look like saying, "Hey, aren't you in my Spanish class?" or "Who wants to go get pizza?" This technique is especially useful when drugs or alcohol are being used, because people under the influence are more easily distracted than those that are sober.

Delegate: Find others who can help you to intervene in the situation. This might look like asking a friend to distract one person in the situation while you distract the other ("splitting" or "defensive split"), asking someone to go sit with them and talk, or going and starting a dance party right in the middle of their conversation. If you didn't know either person in the situation, you could also ask around to see if someone else does and check in with them. See if they can go talk to their friend, text their friend to check in, or intervene.

Delay: For many reasons, you may not be able to do something right in the moment. For example, if you're feeling unsafe or if you're unsure whether or not someone in the situation is feeling unsafe, you may just want to check in with the person. In this case, you can combine a distraction technique by asking the person to use the bathroom with you or go get a drink with you to separate them from the person that they are talking with. Then, this might look like asking them, "Are you okay?" or "How can I help you get out of this situation?" This could also look like texting the person, either in the situation or after you see them leave and asking, "Are you okay?" or "Do you need help?"

Sexual Assault Risk Reduction

Most sexual assaults among college students involve people who know each other, and the majority involve use of alcohol or other drugs. Whether someone is sober or under the influence of alcohol or other drugs, they are not at fault if they are sexually assaulted.

Anyone can be sexually assaulted, and there are no sure means to prevent sexual assault. The only people who can prevent sexual assault are those who perpetrate it. However, you can take steps to lessen the likelihood that you or your friends will be assaulted or will assault someone.

Here are some tips to consider when you go out:

- Know where you are going and speak up if you are uncomfortable with the plans.
- Communicate with your partner: NO MEANS NO;
- CLEAR verbal or non-verbal CONSENT. That means YES.
- Know that drinking and drug use can impair your judgment. You might not be able to make the same decision you would make if you were sober.
- If you drink, drink responsibly: eat a full meal before going out, have a glass of water between each drink, stick to one type of alcoholic beverage, know your limits and don't go beyond them, have a designated driver, and don't let anyone else make the decision of how much you will drink.
- Only drink something that you poured yourself or that comes in a pre-sealed container, and don't drink something that has been left unattended. Mixed drinks can have more alcohol in them than you might want to drink. Also, drugs (e.g., Rohypnol, GHB) can be dissolved in a drink, causing side effects such as nausea, dizziness, disorientation, &/or loss of consciousness.
- Use the buddy system and look out for each other. Don't go anywhere with someone you don't know well. If you do leave a party with a new friend, tell the friends you came with where you are going and when you are coming back. If you are worried about a friend's safety, tell them.

Reduce the Risk of Committing Sexual Assault

- Listen carefully. Take time to hear what the other person has to say. If you feel they are not being direct or are giving you a "mixed message" ask for clarification.
- Don't fall for the cliché "if they say no, they really mean yes." If your partner says "no" to sexual contact, believe them and stop. If they seem uncomfortable or uncertain, stop and check in. It is never acceptable to force sexual activity, or to pressure, coerce, or manipulate someone into having sex, no matter the circumstances.

- Don't make assumptions about a person's behavior. Don't assume that someone wants to have sex because of the way they are dressed, they drink (or drink too much), or agree to go to your room. Don't assume that if someone has had sex with you before they are willing to do so again. Also don't assume that if your partner consents to kissing or other sexual activities, they are consenting to all sexual activities. Obtain clear consent for each sexual activity.
- Be aware that having sex with someone who is mentally or physically incapable of giving consent is rape. **If you have sex with someone who is drugged, intoxicated, passed out, or is otherwise incapable of saying no or knowing what is going on around them, you may be guilty of rape.**
- Remember, sexual assault is a crime punishable via campus conduct, criminal, and civil proceedings.
- Be careful in group situations; resist pressure from friends to participate in violent acts.

Get involved if you believe that someone is at risk. If you see someone in trouble or someone pressuring another person, don't be afraid to intervene - or get help to do so.

Reduce the Risk of Being Sexually Assaulted

- Know your sexual intentions and limits. You have the right to say "NO" to any unwanted sexual contact. If you are uncertain of what you want, ask your partner to respect your feelings.
- Communicate with your partner. Do not assume that someone will automatically know how you feel or will eventually "get the message" without you having to say anything. Just as it's okay to say "NO" to unwanted activities, it's okay - and important - to give clear consent to activities in which you would like to engage. Avoid giving "mixed messages"; back up your words with a firm voice and clear body language and "Yes".
- Be aware that some people mistakenly believe drinking, dressing provocatively, or going to your or someone else's room means you are willing to have sex. Be clear up front about your limits in such situations.
- Listen to your gut feelings. If you feel uncomfortable or think you might be at risk, **leave the situation immediately and go to a safe place.**
- If you feel you are being pressured or coerced into sexual activity, you have a right to state your feelings &/or leave the situation. If you are concerned about the other person becoming angry, it is okay to make up an excuse to leave or create time to get help.

- Attend large parties with friends you trust. Agree to “look out” for one another. Leave with the group, not alone. Avoid leaving with people that you don’t know very well.

- Learn the locations of Emergency Phones on campus (refer to Emergency Telephones on Page 7) and use them if you see anyone or anything that looks suspicious
- Park your car in well-lit and easily viewable public areas at all times on and off campus.
- When or if walking alone, walk confidently and quickly to your destination. Have a cellular telephone readily available, and consider the option of carrying a personal defense item such as pepper spray. (*If you do, take a class on how to use it properly*)

Campus Education and Prevention Programs

The Department of Human Resources, under the coordination of the Cuesta College Title IX coordinator, provides ongoing mandated staff training about sexual violence awareness in compliance with the Violence Against Women Act (VAWA). This training takes the form of on-line courses offered via the campus-wide email system and also as part of the new employee orientation.

The Admissions Office is responsible for providing sexual assault awareness and prevention material to all incoming students during the online, My Cuesta, registration process. The material includes awareness about both Clery and SaVe Acts, reporting sexual assault, bystander intervention, definitions of sexual crime, domestic violence, dating, and stalking, as well as provides a link to the Cuesta College Annual Security Report.

The Cuesta College Police Department supports Sexual Violence Awareness and Prevention by providing a link on the department webpage that contains sexual assault and violence prevention information, providing a flier in our lobbies and at festivals, as well as links to outside resources available in the local community. Reporting: Sexual Assault, Dating Violence, Domestic Violence and Stalking

It is not your fault!

If you are a survivor of sexual assault, dating violence, domestic violence, or stalking, you have the option to report this crime to law enforcement authorities or not. The Cuesta College Police Department will assist you in notifying the proper law enforcement authority where the crime occurred, whether or not it occurred on campus. We will also assist you in obtaining other resources to assist and support you.

Cuesta College strongly encourages all members of the campus community who believe they are victims of sexual assault, domestic violence, dating violence, and stalking to immediately report the incident. Timely reporting is an important factor in the subsequent investigation and prosecution of sexual assault cases should the survivor desire to do so.

We recommend the following steps after an assault:

- **Go to a safe place.** Your safety is our first concern
- **Call for help.**
 - On campus: Cuesta College Police Department, **(805)546-3205** or from a campus phone **x3911**.
 - Off campus: **911**.
- **Get medical attention**, regardless of whether you choose to report the assault to law enforcement.
- **Try to preserve all the physical evidence of the assault.**
 - Do not wash, use the toilet, bathe or change clothing if you can avoid it. If you must change clothes, place all clothing you were wearing at the time of the assault into a paper bag.
- **Call an advocate, counselor**, friend, family member, or someone you trust for support and assistance.

Response Procedures

The Cuesta College Police Department will, upon receiving the report of a sexual assault, domestic violence, dating violence, or stalking, (*whether or not the offense occurred on or off campus*), **provide the survivor with a handbook** that contains information about her/his student or employee rights as well as existing services, both on-campus and in the community. These services include counseling, medical assistance, survivor advocacy, legal assistance, and other services.

Additionally, Cuesta College will provide, as necessary, **options** and **protective measures** for the survivor to choose should her/his academic situation, work environment, or transportation needs change as a result of the assault. Reasonable accommodations will be granted, whether or not the survivor chooses to report the crime to law enforcement authorities. All of the aforementioned services will be accomplished while maintaining the confidentiality of the survivor.

When reporting a crime of sexual assault, dating violence, domestic violence, and stalking to the Cuesta College Police Department:

- Confidentiality and the protection of the survivor's name and personally identifying information will be of the highest priority if she or he chooses not to have their name released.
- A survivor's decision to prosecute does not have to be made during the initial report to the police. Police and college officials, along with an advocate of their choice (RISE, a relative, a close friend) will assist the survivor regarding determining what extent the subsequent investigation will unfold.
- Police and college officials, and the survivor's advocate will also answer any questions, explain available options, and connect the survivor with counseling and support resources.
- A survivor will be interviewed at a location of their choice. A survivor will be accompanied by an advocate/confidant of their choice (RISE advocate, relative, close friend) who will accompany them during the Police and District Attorney interview's, forensic exams, and any/all court proceedings.

Police officers may arrest the suspect and/or forward the case to the District Attorney's Office for review and a decision regarding filing criminal charges. Depending on the circumstances of the case, the suspect could be jailed and retained or released on bail if arrested.

Restraining Orders: The Cuesta College Police Department, the District Attorney's Office, and/or advocates can assist a survivor in obtaining a criminal protective order "restraining order" and/or other lawful court orders against the suspect.

**If you feel threatened by the suspect, you should immediately contact the nearest law enforcement agency to assist you.*

Confidentiality:

Cuesta College is bound by State law to uphold the right to confidentiality of any survivor who contacts the College to report an incident of sexual assault. The College will not take any action without the survivor's consent, prior knowledge, and /or permission. Any violation of the California Code of Regulations, Title 5, Section 41301, by a student or recognized student organization, and any violation of faculty or other employee codes of conduct concerning sexual assault will be investigated for possible disciplinary and/or legal action.

Disciplinary Procedures

Cuesta College does not tolerate sexual assault, domestic violence, dating violence, or stalking in any form. Even if the survivor or the criminal justice authorities choose not to prosecute, Cuesta College can still pursue disciplinary action if the assailant is a student, staff, or faculty member. If the incident involves someone under the age of 18 years, the appropriate legal guidelines and notifications to parents/guardians will be followed. Incidents involving non-members of Cuesta College community will be processed according to local and state laws.

Cuesta College is committed to conducting a prompt, fair, and impartial investigation and resolution in dealing with all sexual assault, domestic violence, dating violence, and stalking investigations. The standard by which the final determination regarding guilt, will be a preponderance of evidence, based on Title IX guidelines.

Possible sanctions to be imposed following the final determination of an on-campus disciplinary procedure regarding sexual assault, domestic violence, dating violence, and stalking, maybe one or any combination of the following:

- Warning
- Censure
- Disciplinary Probation
- Restitution
- Interim Suspension
- Suspension
- Dismissal
- Expulsion

In all cases, the accuser and the accused are entitled to the same opportunities to have others present including the opportunity to be accompanied by the advisor of their choice during a campus disciplinary proceeding. Both the accuser and the accused shall be informed, in writing, of the outcome of any campus disciplinary proceeding brought about alleging sexual assault, domestic violence, dating violence, and stalking.

Disciplinary proceedings shall be conducted by officials who, at a minimum, receive annual training on:

- Issues related to dating violence, domestic violence, sexual assault and stalking
- How to conduct an investigation and hearing process that protects the safety of survivors and promotes accountability.

Student Discipline

Disciplinary proceedings for students at Cuesta College are governed by guidelines contained in the Cuesta College Board of Trustees Manual Section AP 5520 - Student Discipline Procedures and BP 5520 – Student Discipline.

- A student(s) may be disciplined for improper conduct when such conduct is a part of any college activity.
- The Vice President of Student Services or designee may appoint faculty, student, individual, or committee advisors, to consider potential disciplinary action, but has the final authority for administration of student discipline except that expulsion requires approval by the Superintendent/President of the college.
- The Vice President of Student Services or designee may impose any discipline provided herein when there is reason to believe that substantial grounds exist for such discipline.
- During the term of any discipline which does not terminate student status, students continue to be subject to District policies, regulations, and procedures.
- Pre-discipline conference/notice: Students charged with misconduct shall be provided with written notice to meet with the Vice President of Student Services or designee regarding the basis for possible disciplinary action. The notice must be given at least twenty-four (24) hours prior to the scheduled appointment.
- The meeting with the Vice President of Student Services or designee should include:
 - A written statement of charges to the student(s);
 - A reasonable opportunity at the meeting for the student(s) to personally answer the charges;
 - Following the meeting, the student(s) shall either accept the disciplinary action, if any, or within forty-eight (48) hours (two school

days) following receipt of the written notice of proposed disciplinary action, file at the office of the Vice President of Student Services or designee a written notice of intent to appeal to the Student Conduct Appeals Committee.

Appeal

Level I

- The student(s) shall file with the Appeals Committee, within twenty-four (24) hours (one school day) following filing of a notice of intention to appeal, a specific written response to each of the charges. Any charge to which the student(s) does not respond shall be deemed to be true.
- The Appeals Committee shall include a hearing officer appointed by the Superintendent/ President, administrator (Vice President of Student Services may not serve), faculty member appointed by the Academic Senate, and a student representative appointed by the Associated Students of Cuesta College.
- A meeting of the Appeals Committee shall be convened not earlier than twenty-four (24) hours after submission of the student's response to the charges, to hear the appeal and to make a decision in the case.
- The hearing before the Appeals Committee is not a judicial proceeding. The Appeals Committee recognizes the student's right to a fair opportunity to hear the charges and evidence in support thereof, right to present oral and documentary evidence on his/her behalf, right to present a written argument on conclusion of the hearing and right to have an accurate copy of the minutes of the hearing furnished to the student
- The appeals committee shall submit its decision to the student within ten (10) working days of the hearing.

Level II

- Within twenty-four (24) hours (one school day) after receiving the decision of the Appeals Committee, the student(s) may appeal the decision in writing to the Superintendent/ President. Such appeal may be based only on the grounds that:
 - Required procedures have not been followed and the student(s) has/have been demonstrably damaged;
 - There is insufficient evidence to support the decision of the Appeals Committee;
 - One or more members of the Appeals Committee have, prior to the hearing, formed an opinion as to whether the student(s) has/have or has/have not committed the acts with which charged; and must include all supportive evidence.

- The Superintendent/President will evaluate the evidence and submit findings in writing to the student within fifteen (15) working days after receiving the appeal.

Level III

- Every student has the final right of appeal to the Board of Trustees when dismissal or expulsion has been imposed.
- A final written appeal may be made to the Board of Trustees within thirty (30) working days of the written response of the Superintendent/President. The Board will evaluate the evidence and render its decision within thirty (30) days of the initial meeting of the Board at which the matter is discussed.

Employee Discipline

Disciplinary proceedings for employees at Cuesta College are governed by guidelines contained in the Cuesta College Board of Trustees Manual Section BP 4500, 4510, and 4520, along with Education Code sections 87660-87683, 87730-87740, along with applicable sections of the Collective Bargaining Agreements for those employees. Information on the collective bargaining agreements can be found at the Department of Human Resources website at the following address:

Any employee designated as a permanent employee may be dismissed, suspended or demoted for cause during the term of the annual contract.

- Suspension means either temporary removal of an employee from the employee's position with loss of pay or removal preliminary to investigation of charges pending demotion or dismissal.
- Demotion means reduction of an employee from a class having a higher salary rate to a class having a lower salary rate.
- Dismissal means separation, discharge or permanent removal for cause of an employee from the employee's position in accordance with the provisions of the Education Code and these rules. (E.C. 88122, 88123)

Prior to initiating dismissal or other disciplinary action, the district President/Superintendent or designee shall, unless circumstances require immediate action, attempt to meet with the employee to provide the opportunity for the employee to explain his/her conduct and to comment on the proposed discipline.

Dismissal or other discipline of a permanent classified employee, other than oral or written reprimand, shall be instituted by serving upon the employee personally or

by registered mail, a written notice of specific charges, a statement of the employee's right to a hearing before the Board of Trustees and notice that the employee may request a hearing before the board by delivering a written request to the Office of the President/Superintendent not later than five (5) calendar days after receipt of the statement of charges. A form for which shall accompany the notice of charges. At such hearing, the district shall have the burden of proving cause for discipline. The decision of the board at such hearing shall be final and shall be provided to the employee in writing.

If no timely request for hearing is received, the discipline or dismissal shall take effect upon the expiration of the time for filing the request. If a hearing is requested within that time, the discipline or dismissal shall be stayed until the board's decision. If sustained by the board, the discipline or dismissal shall then be effective immediately unless the board otherwise provides.

Where the President/Superintendent determines that the needs of the district so require he/she may order the suspension of the employee with or without pay pending a request for hearing (if any) and pending completion of the hearing process. In such cases, the board shall determine as part of any appeal whether to sustain or reverse the suspension and any denial of compensation.

No discipline shall be imposed for any cause arising more than two years prior to the notice of discipline or arising during the employee's probationary status. Provided, however, this statute of limitations shall be tolled for that period of time that the cause is unknown or cannot reasonably be presumed to be known to the Board of Trustees or the President/Superintendent.

Resources for Survivors

Cuesta College is committed to ensuring that all survivors of sexual assault, domestic violence, dating violence, and stalking, are treated with sensitivity, dignity, and confidentiality. Survivors, whether they are students, staff, faculty, or visitors are provided assistance with obtaining medical treatment, counseling assistance, and resource information specific to what they have experienced.

Every effort is made to ensure that our educational environment promotes and assists prompt reporting of crimes and provides compassionate support services for survivors. The following is a list of current resources for survivors available both on-campus, and in the surrounding community.

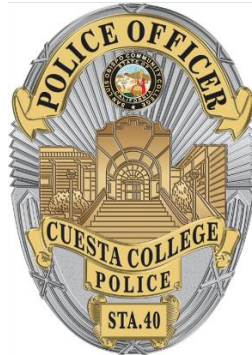
